MESSAGE FROM THE PRESIDENT



Dear Members,

It has been a very busy period since the last newsletter, with the first UCI Management Committee meeting of the year, followed by the elective Congresses of three Continental Confederations.

Members of the UCI Management Committee met in Arras (France) on 31st January and 1st February during the 2025 UCI Cyclo-cross World Championships, which were organised close by in Liévin. We took some important decisions for our sport, not least in terms of the health of riders by banning repeated inhalation of carbon monoxide. You can read more about this and other decisions in the press release published on the UCI website following the meeting.

After Oceania in January, this month I had the enormous pleasure of attending the Congresses of the Asian Cycling Confederation (ACC, in Bangkok, Thailand, on 6 February), of the African Cycling Confederation (CAC, in Cairo, Egypt, on 16 February) and of the Pan American Cycling Confederation (COPACI, in Panama City, Panama) on 25 February. All three meetings were precious opportunities for me to discuss important matters face-to-face with representatives of different National Federations, all committed to developing our sport in their respective countries.

My congratulations go to Mr. Dato' Amarjit Singh Gill for his election to the head of the ACC, succeeding Mr Osama Ahmed Abdullah Al Shafar, who I sincerely thank for his eight years at the head of the Continental Confederation. I also congratulate Mr Yao Jean-Marie Allah-Kouamé, the new President of the CAC, replacing Dr Mohamed Wagih Azzam to whom I express my gratitude for his 20 years in this role. There is no change at the head of COPACI, and I my very best wishes go to Mr José Manuel Pelaez as he embarks on a new four-year term as President.

I was in Kigali, Rwanda, on 23 February for the official opening of the latest UCI World Cycling Centre (WCC) Regional Development Satellite, which will operate out of Bugesera, Musanze and Rwamagana. The UCI WCC now has a network of 11 satellites worldwide, including two in Africa with the UCI WCC Continental Development Satellite in Paarl, South Africa. More about this in the WCC Corner at the end of this newsletter.


We have already crowned our first 2025 UCI World Champions, for cyclo-cross and for snow bike. The UCI World Championships for these two spectacular winter disciplines were held respectively in Liévin and in Châtel, Haute-Savoie, France.

Finally, I would like to congratulate Mr. Ara Sadoyan on his election as President of the Armenian Cycling Federation, Mr Buyantogtokh Gursoronzon on his election as President of the Mongolian Cycling Federation, Mr Khireddine Barbari on his re-election as President of the Algerian Cycling Federation, Mrs Carolina Poussier Milhau on her election as President of the Andorran Cycling Federation, Mr Cordiano Dagnoni on his re-election as President of the Italian Cycling Federation, and Mr Sang-hyun Lee on his election as President of the Korean Cycling Federation.

On behalf of the UCI, I thank them for their continued efforts in promoting cycling and wish them every success and satisfaction in their respective roles.

It has been a great launch to the year, and we can only look forward to the coming months!

Registration of UCI Women's Continental Teams and UCI Continental Teams for the 2025 season

A total of 37 UCI Women's Continental Teams and 176 UCI Continental Teams from the five continents have been registered. The list of teams with a compliant file is now published on the [UCI website](#).

We would like to remind all parties that they should consult the UCI website before each event to make the necessary checks. We therefore invite teams and National Federations to ensure that all information relating to teams and their members has been entered correctly on the UCI website and to send an email to road@uci.ch if there is any issue. Only riders and Sport Directors whose names are correctly published on the UCI website will be permitted to participate at

REMINDER: Participation of UCI Continental Teams and UCI Cyclo-cross Professional Teams in UCI ProSeries events

We remind you that UCI Continental Teams and UCI Cyclo-cross Professional Teams can only be invited and permitted to participate in UCI ProSeries events if they are registered in the reinforced anti-doping programme. This registration was made upon reception of the payment of an additional anti-doping contribution and submission of the online form via the dedicated link by 31 December 2024 (see p.29 of the "2025 UCI Instructions for Registration").

Any team that wishes to participate in UCI ProSeries events but did not proceed with the payment within the deadline will not be authorised to participate in these events during the 2025 season. The list of teams authorised to participate in UCI ProSeries events is available on the [UCI website](#).

UCI ProSeries event organisers can only invite the UCI Continental Teams and UCI Cyclo-cross Professional Teams featuring on this published list.

REMINDER: Participation rules (art. 2.2.001 of the UCI Regulations)

As per article 2.2.001 of the UCI Regulations, "Riders belonging to a team registered with the UCI with the same paying agent or main partner may not compete in the same race except in the case of an individual event." Similarly, all affiliated club teams with the same paying agent, team representative or main sponsor as a UCI Team must be declared to the relevant National Federation. We invite all National Federations that have not yet informed the UCI to do so as soon as possible by writing to road@uci.ch and to immediately signal any change occurring during the year.

The list of teams concerned by the provisions of article 2.2.001 of the UCI Regulations for the 2025 season is available on the [UCI website](#).

REMINDER: Mandatory invitations to road races (art. 2.1.007bis, 2.14.020, 2.14.021, 2.14.038, and 2.14.051 of the UCI Regulations)

The UCI Sports Department has published the list of teams to receive mandatory invitations for road events. This is available in the UCI Regulations section of the [UCI website](#).

As per article 2.1.007bis of the UCI Regulations, these provisions concern the UCI WorldTour first and foremost, with UCI ProTeams LOTTO and ISRAEL – PREMIER TECH receiving a mandatory invitation to all the events on the circuit and UNO-X MOBILITY being invited to the one-day races on the UCI WorldTour.

Regarding the UCI Women's WorldTour, in addition to the UCI Women's WorldTeams registered for the 2025 season, EF EDUCATION - OATLY and VOLKERWESSELS CYCLING TEAM, as the two best UCI Women's Continental Teams of the final 2024 UCI World Ranking, must be invited to all UCI Women's WorldTour events by their respective organisers.

As a reminder, these teams must confirm their participation to the respective organisers at the latest 70 days before the event. Failing this, the concerned team will lose its automatic invitation.

Regarding the UCI Continental Circuits events (ME and MU):

Organisers of Class 2 events in the UCI Europe Tour, as well as organisers of Class 1 and Class 2 events in the UCI America Tour, UCI Asia Tour and UCI Oceania Tour must invite the top three UCI Continental Teams of the final 2024 classification by team for the relevant continental circuit of the event;

Organisers of Class 2 events in the UCI Africa Tour must invite the top three national teams of the final 2024 UCI Africa Tour classification by nation.

The teams, together with their contact information, are listed in the "Mandatory Invitations to 2025 events" published on the [UCI website](#).

Finally, regarding the UCI Nations' Cups (Under 23, Men Junior and Women Junior), the organisers must also send an

invitation to the teams or nations in the document as per the provisions of articles 2.14.020, 2.14.021, 2.14.038, and 2.14.051).

REMINDER: 2025 licences

In order to make the rider and staff confirmation process easier at the start of the first races of the year, National Federations are requested to ensure, as soon as possible, that the status of all their licensees registered in UCI Teams, are updated on the UCI DataRide platform for the 2025 season.

Training compensation fees

We would like to remind National Federations that following the introduction of the training compensation fee, they are responsible for sending invoices to professional teams at the time of a rider's first neo-professional contract.

A document listing the riders eligible for registration with 2025 professional teams, together with all the relevant information, has been sent to them. In the event of any doubts or difficulties with this system, the UCI Road Department's riders and teams unit remains at the disposal of the National Federations.

2025 UCI Event Safety Manager Course

From February 17 to 20, 112 UCI Event Safety Managers from race organisations and National Federations participated in the UCI Event Safety Manager online course. The programme covered key aspects of race safety, including the new regulations on yellow cards and an overview of SafeR's work. Following this intensive training, 99 successfully passed the exam and obtained their certification.

A new edition of the course will be offered in 2026. Race organisers and National Federations will be notified in due time with details on registration.

2025 UCI Road World Championships (21-28 September 2025)
